An art installation featuring a giant wall labelled "Utopian Alternative" created by artist Jeremy Deller was forcibly removed on Tuesday morning, according to reports. The huge horizontal orange lettering features the words "Behind the lines of the 'Inhuman' society written across the face of an unnamed child". It

also has a picture of a corpse in a body bag. An accompanying banner says: "On display at the World Economic Forum in Davos in January, 2018. The erection of this wall in this location was deemed to be an immediate threat to public order." The installation was commissioned by Mr Deller and is part of a large exhibition of work by British artists curated by Peter Weibel, director of the ZKM, the museum of contemporary art in Karlsruhe, Germany. The decision to remove it on the day it went on display - the first day of the highly exclusive annual meeting of major global businesses - was met with widespread criticism. As the backlash mounted, the artist issued an apology, saying: "I would like to apologise to all those who have been offended. It's been a big wake-up call for me."
